The Orrville Board of Education met for the Regular Meeting on June 15, 2023 at 7:00 a.m. in the IRC of OHS. Employees present were Jon Ritchie and Mark Dickerhoof.

Pledge of Allegiance

Roll Call - Mrs. Corfman, Mr. Lorson, Dr. Roadruck, Mrs. Stark and Mr. Steiner were present.

<u>Public Participation</u> - None at this time.

- 1. The time limit of presentation will not exceed five minutes per individual. No more than one-half hour shall be devoted to public input.

Mike Hamsher, 7535 Black Diamond Rd, Marshallville, read the following statement; To the Orrville Board & Superintendent:

I am the teacher whose career and reputation you ruined. The high school principal is fond of saying "Don't Trust Kids", yet, in this case, you believed kids lock, stock, and barrel regardless of the facts, inconsistencies, or flat out falsehoods. Not once did a school official or administrator reach out to me to hear my side of any allegation until the Superintendent held the Loudermill hearing on August 26 - a full 6 months post removal. I realize that the District needs to address allegations, but it appears that I was the victim of a witch hunt and railroaded process.

Do you even know that not one time did the Superintendent or Title IX Coordinator hold to the timelines set forth in your own board policy during this process? As an example, Board policy says that the decision maker would generally be done in 60 days; we did not even receive the preliminary investigatory report for 118 days. Did you know that your own board policy procedures and state law were not followed during this process? Confidentiality as spelled out in your policy and the ORC seemed to be an afterthought. For example, my name was shared by the superintendent on the radio and in print regarding the allegations. Sharing executive session information seemed to not be taboo as it is spelled out in the ORC. It also appears that no one looked into the character of the accusers nor was there any followup when one of the accusers recanted and another admitted making the story up. In addition, Wayne County Children's Services investigated all of the accusers' stories and found in each case that each story was unsubstantiated.

Rather than sitting in your glass houses throwing rocks and listening to internet trash, it may be more beneficial for you to learn what goes on in the day to day operation of the District. If you really want to lead this district and be the educational leaders that you claim to be and the community thinks you are, get into a classroom and see what really goes on in your district. Go see what teachers really do and the lengths they go to to educate children in their classrooms. I set before you a challenge: If each of you visited one classroom once a week for a school year, the five of you would be able to be in every single classroom in the district at least once among you. That is an investment of less than an hour a week to become better leaders. Some of you spend less than that in governing this district. See, it is hard for those who have not been in a classroom to fully understand the sacrifices, procedures, and real world happenings that go on

during the educational process. You, as elected officials, owe it to your constituents to know what goes on in the organization that you lead and not to just take the jaded word of one of your employees.

I would also ask you to have the guts to publish these comments in their entirety just as you published the comments read by the Vice President of this board in the minutes of the September 15, 2022 meeting. It is interesting that in those September 15 remarks, it was mentioned at the beginning that decorum stated that personnel matters were not fodder for public comment, yet the VP spent the next 3 ½ paragraphs (approximately 2 ½ minutes) reading a statement regarding my personnel matters. The Board President was also quoted in the local paper following that meeting stating that the Board had gotten the conclusions of 3 separate investigators that said I was responsible for sexual harassment. This is another falsehood that seemed to be put out there to try and control the narrative. In actuality, there was one investigator who interviewed all parties and was charged with only compiling those interviews; one Decision Maker who read those collections and rendered a determination (never talking to any of the interviewees personally); and one Appeal Decision Maker who rendered a decision on the process - not the validity of the claims. So you see, only one person made any conclusions regarding the veracity of the allegations and this person did not even ask to speak with me or any of the students.

It is also intriguing to note that the Decision Maker used to work with the Board Attorney. He was trusted enough to render a determination - a determination, by the way, which is based on the "preponderance of evidence." As a review, "preponderance of evidence" means it is not that anything actually occurred, only that in the decision maker's *opinion*, it is more likely than not that it **might** possibly have happened. There is a lot of uncertainty there. There was no guilt assigned - even he said in his report that his was not to determine guilt but only a determination. That is a big difference. While trusted enough to read a compilation of interviews, he also was not trusted enough to adhere to the recommendations in his report; namely to put me back in the classroom.

The next time this happens - and it will; for it is not if but when, now that you have allowed the students to say what they will and give credence to it - I hope you offer the next person a more fair and genteel process.

Lacey Handwerk, 1110 Dogwood Dr, Orrville, addressed the Board concerning supporting teachers when students make allegations against teachers.
