The Orrville Board of Education met for a Special Meeting on October 19, 2021 at 5:30 p.m. in the OHS Auditorium. Employees present were Jon Ritchie and Mark Dickerhoof.

Public Participation:

The following addressed the Board:

Dan Ciammaichella, 4783 Dalton Fox Lake Rd, stated he is not against masks for sick people. He does not want masks for healthy students. He said he is part of a group that will file a class action lawsuit against districts that require masks.

Jamie Kovocs, 2238 Terrapin Trail, stated that her daughter was quarantined and she had nothing for her to do. She said masks are doing harm to the students mental health.

Aaron Shultzman, 2020 Sunnyview Lane, stated that masks do not work and kids don't wear them outside of school. He is not in favor of the mask requirement.
